## Tournament Rules

**Current IJF rules with the following safety modifications will govern:**

- Shime waza (chokes) are allowed for novices
- Kansetsu waza (arm locks) will only be allowed for nikkyu (2<sup>nd</sup> kyu) and above
- Current IJF medical rules will apply to all Senior Divisions
- The CARE system will not be used and 3 referees will be used as a modification
- The competition area will be the modified 6 meters with a 3 meter safety zone. There will be no adjoining competition spaces.

## Format & Divisions

- Brackets will consist of 3 – 5 person pools for round robin to maximize the number of matches for participating judoka
- Weight classes will be separated into Light, Medium and Heavy and will be determined by participants. Gender will be separate. Brown belt will be separate division, white and colored belts may be mixed depending on participation. Age categories are 13-15, 16-17, and 18 and up.
